DAY 1 OF THE 41ST IAFEI WORLD CONGRESS

The 41st IAFEI World Congress in Beijing, China was held on 17-18 September 2011 at the Crowne Plaza Park View Wuzhou Beijing. The theme chosen for this year's congress was "Financial Leadership and Business Development in a New Reality." The program consisted of speeches from several financial and accounting experts and panel discussions which were scheduled for one and a half days.

There were a total of 400 delegates (75 foreign and 325 Chinese) who attended the congress.

"The 41st IAFEI World Congress in Beijing offered a broad range of subjects and speakers from around the world. Among them, the subject 'role of the CFO, its key elements, and the growing activity portion and importance of dealing with corporate strategic issues' received broad coverage. As to China itself, in the state owned corporations there is an ongoing transformation of the chief accountant role into the CFO role, a transformation which is in full swing.
